About the course

The international semester “Business in the Knowledge Society” is aimed at both bachelor degree students and graduates from different study programmes and backgrounds, especially business and management, IT and computer science and social sciences. Conceived as an interdisciplinary approach to study abroad, it combines academic preparation with the direct experience of an international setting and culture.

Course overview

The international semester programme is composed of 6 or 7 modules:

- Portuguese for Foreigners I (4 ECTS)
- Portuguese for Foreigners II (4 ECTS)
- Business Information Management and Systems (5 ECTS)
- The United States of Europe: past, present and future (6 ECTS)
- Entrepreneurship (5 ECTS)

- Interdisciplinary Project (6 ECTS)

Table 1 presents an overview of the course contents and study load.

Teaching methods emphasize active student participation and involvement. The emphasis will be on lectures as well as on learning-by-doing. In addition to lectures, case studies, group discussions, field trips and study visits are an integral part of the learning process, so that students will be able to acquaint themselves with Portuguese culture and learn more about particular issues of doing business in Portugal.

Academic recognition
